Renee Johnson, treasurer, reported that the 05 taxes are done. The 2006 books are going well. Renee will file the 990 form with the Attorney General's Office. Until the paperwork is filed, we cannot solicit funds.

She also went over a quick balance sheet showing income vs expenses. Unfortunately, we have more money going out than coming in – which resulted in our phone service being cut off for a short time. Thank you members who helped pay the bills. Some members have chosen to help by sending extra cash with their dues. Our monthly expenses are \$3,000, so it is up to the whole community to keep us going.

Curt LaClaire said Tribal Council Members will be calling everyone in our files to update our records and to inform them of their membership status. Payments books will be mailed out soon.

The city of Mendota waived our business license fee. Jim Anderson has a new court date for the treaty issue. The pre-trial is set for May 7th, 2007 and the trial will begin May 10th. The dates may change, so please call for more information.

Wally Ripplinger has accepted our request to be head dancer at the Pow Wow. Please call office if you would like to be on the committee.

We are looking for an event coordinator for a wild game feed to be held in the fall. If interested, please contact the tribal council.

Please help our community to raise funds by signing up with Food Perspectives; a taste test company. If thirty new people sign up MMDC will receive \$100.00. You will be paid for your time also. Taste testing is usually every month or every other month and money will be paid to us every time you participate. Call the office if you wish to sign up. Kathy LaClaire will be taking photos for ID cards soon. There will be a \$5.00 charge for the cards.

Members have six months to catch up on their dues. If not caught up by September, their membership status will become "inactive".

The changes in our constitution and by-laws were approved by the community.

The revisions to the Constitution and Bylaws were passed. We only received six (6) no votes for the Constitution and eight (8) no votes for the Bylaws.

Thank you to those members who questioned the validity of accepting no response as a "yes" vote. I'm glad folks are looking out for our Community's best interest. Accepting no responses as a yes vote is a very common practice. The Community adopted this practice several years ago due to a lack of any response from at least two-thirds of our Community members on some critical issues. To ensure everyone understood this practice, we clearly stated it on the cover letter. We also extended the deadline for returning votes to allow everyone adequate time to respond.

One of the Policy Committee's goals is to create sound written policies for the Community. We need folks who question our current practices and policies on this committee. Please consider getting involved and making a difference. Much of our work can be done electronically and through teleconferences.
